1. **Welcome** – Mr. Henderson called to order the Floyd County Board of Assessors meeting July 29, 2026, at 9:00 a.m.

 - a. The results of the 2025 DOAA Ratio Study was received by Floyd County on the morning of July 29, 2026. The Overall Ratio for the study is 39.90. Other pertinent statistical data can be obtained in the report which is public record.
 - b. The Board discussed asking County Manager Jamie McCord to attend a work session during the upcoming budget planning period.
 - c. The Board asked for an update from TrueRoll and from our Personal Property Audits at their next regular meeting, scheduled for August 12, 2026.
