All Counsel or *Pro Se* parties shall attend the calendar call or comply with the instructions defined in this order. Failure to appear or follow the Court's instructions may result in the dismissal without prejudice of a plaintiff's action or the striking of a defendant's answer, counterclaim, and/or cross claim.

No excusals or continuances will be granted except by prior order of the Court. A Motion for Continuance or Excusal may be considered if it is filed with the Clerk's Office at least (3) days prior to calendar call, and it must state the action to be taken to advance the case and the time necessary to complete the case. **The Court will not accept telephone calls or an email communication requesting a continuance or excusal.**

As to those actions in which there has been no service, Counsel or *Pro Se* parties must seek to perfect service prior to the date of Calendar Call, if they desire to proceed with the case. If service cannot be perfected, the Court will dismiss the case without prejudice, unless good cause can be shown for it to remain open.
