- X. SECOND READING (FIRST READING HELD FEBRUARY 9, 2021 AT 6PM)
 - 1. File SUP21-02-01 requesting a Special Use Permit for a Farm Retreat at 45 Ellis Road, Rome, GA; Floyd County Tax Parcel K16382. The planning staff recommends approve on the condition that the use be limited to a non-profit farm retreat. The planning commission recommended approval (7-0).—MR. WOOD

PRESENTED THE REQUEST TO THE COMMISSION. CHAIR BAGBY OPENED THE PUBLIC HEARING. AMANDA BOHANNAN REPRESENTING THE SWEET COCOON SPOKE IN FAVOR OF THE REQUEST. THE PROPERTY WILL BE USED FOR CHILDREN WITH SPECIAL NEEDS. THEY ARE PLANNING ON BUILDING A PAVILION THAT IS ADA COMPLIANT ALONG WITH A PLAYGROUND AND A BARN. NO ONE SPOKE IN OPPOSITION. COMMISSIONER MAXEY MADE A MOTION TO APPROVE WITH THE LIMITATIONS RECOMMENDED BY THE PLANNING STAFF. IT WAS SECONDED BY COMMISSIONER WALLACE. COMMISSIONER HANCOCK SPOKE ON THE REQUEST. THE MOTION CARRIED 4-0.

- 2. File SUP21-01-04 requesting a Special Use Permit for a special event venue at 796 Wilkerson Road, Rome, GA; Floyd County Tax Parcel H14W041. The planning staff and commission recommended denial (6-2).—MR. WOOD PRESENTED THE REQUEST TO THE COMMISSION. CHAIR BAGBY OPENED THE PUBLIC HEARING. PATSY TUMLIN, PROPERTY OWNER, SPOKE IN FAVOR OF THE REQUEST. COMMISSIONER WALLACE ASKED ABOUT THE HOUSE THAT IS 150' FEET FROM THE PROPERTY. MS. TUMLIN RESPONDED THAT IT WAS OWNED BY A FAMILY MEMBER. COMMISSIONER MAXEY MADE A MOTION TO DENY WITHOUT PREJUDICE TO ALLOW THE APPLICANT TO REAPPLY AFTER SATISFYING THE PLANNING STAFF AND PLANNING COMMISSION. COMMISSIONER WALLACE SECONDED THE MOTION. THE MOTION CARRIED 4-0.
- **3.** File SUP21-02-03 requesting a Special Use Permit for miniature warehouses for the property located at 5850 Calhoun Highway, Rome, GA, zoned Community Commercial; Floyd County Tax Parcel M10Y131. The planning staff recommends denial and planning commission recommended denial (7-2).—MR. WOOD PRESENTED THE REQUEST TO THE COMMISSION. CHAIR BAGBY OPENED THE PUBLIC HEARING. CHUCK HARDIN WITH SOUTHERN ENGINEERING SURVEYS REPRESENTING THE PROPERTY OWNER. NO ONE ATTENDED TO SPEAK IN OPPOSITION. COMMISSIONER WALLACE ASKED IF THERE WOULD BE AN ELECTRONIC SECURITY GATE. MR. HARDIN EXPLAINED YES THERE WOULD BE A SECURE GATE AND THE CONVENIENT STORE IS OPEN 24 HOURS SO THERE WOULD ALWAYS BE A PRESENCE THERE. COMMISSIONER WALLACE ALSO ASKED THE NUMBER OF UNITS. MR. HARDIN REPLIED THERE WOULD BE 300 UNITS. COMMISSIONER WALLACE ALSO ASKED IF WE HAVE OTHER PROPERTIES OF THIS SIZE WITH THIS NUMBER OF UNITS. COMMISSIONER MAXEY MADE A MOTION TO DENY DUE TO THE PROPOSED PLAN NOT MEET THE LONG RANGE GOALS OF THE PROPERTY. IT WAS SECONDED BY CHAIR BAGBY. COMMISSIONER WALLACE ASKED IN REGARDS TO SETBACKS BETWEEN THE REQUEST FOR A SUP AND AN LI ZONING.

THE MOTION FAILED 2-2. (COMMISSIONERS MAXEY AND BAGBY VOTED IN FAVOR OF THE DENAIL. COMMISSIONERS WALLACE AND HANCOCK VOTED IN OPPOSITION OF THE DENIAL.) COMMISSIONER WALLACE MADE A MOTION TO DENY WITHOUT PREJUDICE. IT WAS SECONDED BY COMMISSIONER MAXEY. THE MOTION CARRIED 4-0.
