Approve task order for approval and execution for groundwater, surface water, and leachate sampling and reporting as required by the State of Georgia for Berry Hill and Walker Mountain Landfills in the amount of \$75,688.00 from Solid Waste Management Fund. MR. MCCORD PRESENTED THE ITEM TO THE COMMISSION. VICE CHAIR WATTERS MADE A MOTION TO APPROVE, SECONDED BY COMMISSIONER MAXEY. THE MOTION CARRIED 5-0.
- 4. Approve standard agreement for professional services between Crawford, Murphy, & Tilly, Inc. (CMT) and the Richard B. Russell Regional Airport not-to-exceed \$34,280.00. This agreement addresses the performance of environmental technical support professional services associated with the phased construction of the Runway 1/19 & Taxiway 'A' Extension at the Richard B. Russell Regional Airport. MR. MCCORD PRESENTED THE ITEM TO THE COMMISSION. COMMISSIONER HANCOCK MADE A MOTION TO APPROVE, SECONDED BY VICE CHAIR WATTERS. THE MOTION CARRIED 5-0.
