CHAIR BAGBY CALLED THE MEETING TO ORDER. MR. MCCORD REVIEWED THE AGENDA FOR THE COMMISSION. MRS. GASS REVIEWED THE PROPOSED FY2022 BUDGET. MS. HARMAN UPDATED THE COMMISSION ON THAT LAST CASE BEFORE THE STATE ELECTIONS BOARD.

COMMISSIONER WALLACE MADE A MOTION TO ENTER INTO EXECUTIVE SESSION FOR THE PURPOSE OF DISCUSSING POTENTIAL ACQUISITION OF PROPERTY, AND IN ACCORDANCE WITH O.C.G.A 50-14-3(b2), FOR A MEETING TO DELIBERATE UPON THE APPOINTMENT OF A PUBLIC OFFICIAL, MAINLY THE BOARD OF ELECTIONS. IT WAS SECONDED BY VICE CHAIR WATTERS. THE MOTION CARRIED 4-0, WITH COMMISSIONER MAXEY BEING OUT OF THE ROOM AT THIS TIME.

Layla Shipman, 109 Lookout Circle: "Good afternoon, this message is both from me and Jamie Palmer, Jamie first wanted to say that he was sorry that he could not attend this meeting in person as he had originally planned, we wanted to publicly say that though we may not always agree with your decisions, we fully support this Commission and its continuous efforts to make our community, our home, something better, a better place; at the last meeting, Jamie mentioned a gentleman said something that infuriated him to no end so he felt it was necessary to tell you all or have a surrogate to tell you that he fully supports you, as I do; I am thankful for your friendship and your leadership and again, though we may

not always agree, thank you for showing your true, Conservative leadership through these difficult times, you are appreciated."

- 2. <u>Randy Smith, 19 Bridgeview Drive:</u> "Commissioners, I wanted to thank y'all very much for convening this meeting of course on a regular schedule, and just wanted to stand before you a the Floyd GOP Chairman and tell you how much the executive committee has, I will say, enjoyed and we have also hammered out the nominees we have given you tonight for the Election Board; I wanted to thank you for your consideration, tell you that we have carried on a lot of conversation with a lot of folks and we have done a lot of vetting of those candidates ourselves, and we just feel like we've given you names of folks that would do very very well on the Election Board, we want to thank you again for your consideration and look forward to working with you on many issues of importance here in Floyd County as this next, as certainly as this new year 2022 comes about, thank y'all very much."
- Tommy Couch, 521 E 9th Street: "Chairman Bagby, fellow Commissioners, 3. recently during the Public Participation portion of the last meeting that we had, of the Commission meetings, there's been a request for this Commission based to vote on the will of the people being present either being for or against a certain item, as y'all well know that's not the way our Floyd County government works, at the local level, the Floyd County is a County Manager formed with five council, y'all Commissioners, elected at large by all of the citizens of Floyd County; you are elected based on your past leadership and your vision of the future for this County; based on the elections of voters of Floyd County, the Commissions are authorized, and not only authorized they are required, to conduct the business of Floyd County; sometimes the people of Floyd County might agree with you, sometimes they might disagree, it really doesn't matter that much because you are supposed to get the input from the County officials, experts, and citizens, and based on your best judgement, vote on what you feel is the best for the future of Floyd County; also at the last Commission meeting, we found out that our Election Board Chairman had received death threats, unhinged tweets, and cyberstalking, possibly by some of the attendees of this meeting or those associated with their group, such actions are totally unacceptable in a civil society and should be rejected by all respectful citizens of Floyd County; it is both unpatriotic and un-American; I would like one of these members of this 'respectful group' to assure the Commission that they would never allow or condone such action and any member of their respectful group that participated in such action would be removed; of course if these actions are not condoned, is admission that they support such uncivil behavior; everyone will then realize they are not looking to support the will of the citizens of Floyd County, as reflected in the election of the County Commissioners, and the appointment of the citizens of various Boards.
