Chair Bagby called the Caucus session to order. Mr. Blalock updated the Commission on the Imagine Music Festival that will be held at Kingston Downs in September. Chair Bagby asked that the Commission entertain adding a resolution to the agenda to close a portion of Three Mile Road. Chair Bagby continued with the review of the agenda.

Commissioner Hancock made a motion to enter into Executive Session to discuss personnel and litigation, seconded by Commissioner Maxey. The motion carried 5-0.

IX. SECOND READING/PUBLIC HEARING (FIRST READINGS WERE HELD AUGUST 9, 2022 AT 6PM)

Chair Bagby explained the procedure of the public hearing: each person recognized shall come to the podium and state their name and home address. There is no less than ten minutes provided for all speaking in favor, and no less than ten minutes provided by those speaking in opposition.

1. File Z22-08-02 requesting rezoning from Suburban Residential (SR) to Light Industrial (LI) for the property at 5110 Calhoun Highway, Rome, GA; Floyd County Tax Parcel M10Z118. The Planning staff recommends denial. The Planning Commission voted to deny the request 7-0. — Mr. Wood presented the request to the Commission. Chair Bagby opened the Public Hearing. Seeing no one to speak in favor, Chair Bagby asked if anyone was there to speak in opposition. Mr. Wood read a statement from Mr. Johnny Evans who was unable to attend since he was ill.

SPEAKING IN OPPOSITION:

<u>Mr. Johnny Evans, 5095 Calhoun Highway, Rome:</u> "I'm an old man, I've lived in my house for a long time and I'd like to die in my home, and I'd rather not smell toilets for the rest of my remaining life. I implore you to please deny this request. Thank you."

Seeing no one else to speak in opposition, Chair Bagby closed the Public Hearing. Commissioner Maxey made a motion to deny, seconded by Commissioner Wallace. The motion to deny carried 5-0.

2. File SUP22-08-03 requesting a Special Use Permit to operate a facility for general outdoor entertainment/events of community interest, to include overnight fees, zoned Suburban Residential (SR)/Agricultural Residential (AR) for the property at 125 Davis Road, Cave Spring, GA; Floyd County Tax Parcels F18027, F18026, and F18025. The Planning Staff recommends approval with stipulations. The Planning Commission voted to approve with staff conditions 7-0. — Mr. Wood presented the request to the Commission. Chair Bagby opened the Public Hearing.

SPEAKING IN FAVOR:

<u>Alan Reeves, 475 Davis Road SW, Cave Spring:</u> "Good evening, I have lived there at 475 Davis Road for thirty-three years, I currently own the property that we are discussing, the previous owner gave preference to a local purchaser because of the importance of the Cave Spring Motorcycle Rally, or the Cave Spring Downtown Development Authority sponsored Motorcycle Rally and its criticality to the funding for the DDA. Since that time, we did host the Georgia Mushroom Festival and the evaluation of those two events have indicated that we could potentially host one more in conjunction with the hay harvest, it's a hay field, but that's all we plan to do. It won't be this year though, we had about four inches of rain on the last day of the Motorcycle Rally and a lot of fun can be had in a hayfield with a motorcycle and four inches of rain. I'll reserve any of the time if you have questions."

Seeing no one else to speak in favor, Chair Bagby asked if there was anyone to speak in opposition. Seeing none, Chair Bagby closed the Public Hearing. Commissioner Maxey made a motion to approve with the stipulations recommended by the Planning staff of no more than three (3) events per year, no longer than three (3) consecutive days and two (2) nights, a fifty (50) foot buffer between events and property lines, all event parking be on-site, and all event plans being submitted one month prior to the event to all necessary offices, seconded by Vice Chair Watters.

<u>Chair Bagby:</u> "Mr. Reeves, you clearly understand the stipulations, I think you are in agreement with those stipulations, is that correct?"

<u>Mr. Reeves:</u> "Yes, I submitted kind of a description of what I wanted to do to the Planning department, and it's condensed I guess on this form right here, but it's part of the package but it's three (3) events yes."

<u>Chair Bagby:</u> "Just wanted to make sure that you were there and were in favor, understood the stipulations so that's good."

Mrs. Elrod called the roll. The motion carried 5-0.

3. Adopt an ordinance to amend article 2-18-23 subsections (3) and (9) of the Floyd County, Georgia Code of Ordinances titled "Conditions prerequisite to furnishing towing service at request of county." — Mr. McCord presented the request to the Commission for approval. Chair Bagby opened the Public Hearing. Seeing no one to speak in favor or in opposition, Chair Bagby closed the public hearing. Commissioner Maxey made a motion to approve, seconded by Commissioner Wallace. The motion carried 5-0.

Adopt a resolution by the Board of Commissioners of Floyd County, Georgia regarding the closure of a portion of Three Mile Road, said portion being easterly of the Armuchee Connector and depicted as the area shaded in yellow on the attached Exhibit "A". Chair Bagby presented the resolution to the Commission. Commissioner Maxey made a motion to adopt the resolution. It was seconded by Commissioner Wallace. The motion carried 5-0.
