INSTRUCTIONS FOR SERVICE BY PUBLICATION

If you cannot locate the Defendant, your method of last resort is to serve the Defendant by publishing a legal notice in the Rome News Tribune, the legal organ for Floyd County. Service by Publication may place certain limitations upon your case and may possibly restrict your ability to obtain certain kinds of relief such as child support and/or alimony. If you are able to locate the Defendant, you MUST either have the Defendant sign an Acknowledgment of Service form OR have the Sheriff complete service.

To accomplish service by publication, you must complete the following steps:

- 1. Make a diligent effort to locate the Defendant.
- Complete the Affidavit of Diligent Search below indicating that you have made such an effort.
- 3. Complete the Notice of Publication form.
- 4. Complete the very top portion of the Order of Publication form. The Judge/Clerk will then sign the bottom portion if the order is granted.

In addition to the normal filing fee, you must also pay a publication fee. Please check with the Clerk of the Superior Court to get the current fee amount.
